PROCEEDING OF THE 6th DISTRICT LEVEL RESEARCH-EXTENSION INTERFACE MEETING HELD ON 15th NOVEMBER, 2016

The 6th District level Research-Extension Interface meeting for the Mayurbhanj district was held on 15th November, 2016 under the Chairmanship of Sj.Dharanidhar Patra, Dy. Director Horticulture, Mayurbhanj. The meeting was started at 11.30 AM in the Conference Hall of KVK, Mayurbhanj-1. At the outset, the Senior Scientist & Head, KVK, Mayurbhanj-1 welcomed all the participants and requested the Chairman to preside the meeting. After a brief introduction of the delegates, the Chairman urged for active participation of all in the discussions.

Review of the discussion of the previous meeting and action taken thereof:

. No.	Discussion of the previous meeting	Action taken	
1.	Deputy Director Agriculture, Mayurbhanj and Chairman has suggested to organize the future DLREI meeting at KVK, Mayurbhanj-1 campus instead of Jashipur due to distance factor and all the heads of the line department are facing difficulties to attend. In this regard, the Senior Scientist & Head, KVK, Mayurbhanj-2 stated that this may be intimated to the DPME, OUAT.	This was brought to the notice of the Hon'ble Vice Chancellor, OUAT through the previous proceeding and the Vice Chancellor has approved the proposal. The same was intimated to all the concerned through email.	
2.	As decided in the previous meeting to conduct a joint field visit to the programme area of PD, Watershed, the members urged to fix the date in the present meeting. The representative of the watershed after consulting with his office proposed to visit their area in the first week of November, 2016.	A joint field visit was conducted on 10 th November, 2016 with the following personner to the watershed areas of Kalajhini village of Kuliana block where site for vegetable cultivation in clusters has been selected and KVK will provide seedlings as desired by the District Magistrate and Collector. 1.AAO, AO of Kuliana Block 2. AHO and HEW of Kuliana Block 3. ASCO, Watershed, Mayurbhanj 2.Sr.Scientist & Head, KVK, Mayurbhanj-1	
3.	District Forest Officer seeks technical assistance from the KVK and district agriculture department on the Agro Forestry Scheme and Non Agro Forestry Scheme operated through Forest department.	All are agreed and when required technica assistance will be provided on the agro forestry scheme and non agro forestry scheme operated through forest department.	
4.	The DFO also expressed his thoughts over forest fire. The DDA-Cum-Chairman of the 5 th DLREI meeting advised all the members to aware the villagers during training programme and other extension activities.	KVK in its training programme aware the farmers about the huge loss of forestry resources and its effect on animal kingdom due to forest fire and emphasized on check loss of forest resources.	
5.	The Senior Scientist & Head, KVK, Mayurbhanj-2 suggested providing net to the villagers residing near by the forest area for collection of Mahua flower. So that, manmade fire can be reduced and we can save the forest from fire.	DFO agreed and planning to provide net to the villagers residing nearby the forest area in coming future, so that people will not put fire on the dry leaves while collecting of Mahua flower.	
6.	DFO proposed to reduce the biotic pressure of Similipal bio reserve forest, the agriculture department may distribute small agriculture machinery on subsidised rate among the farmers nearby forest area	department through the previous proceeding.	
7.	The DFO also urged the line department official to provide implements for doing plantation in the forest.	This has also been communicated to the line department through the previous proceeding.	
8.	The DFO invited suggestion of the expert on complete eradication of Lantana Camara Weed as it is a major challenge in Similipal bio reserve forest.

9.	The DPD, ATMA invited suggestion of the members for preparation of action plan for Rabi ATMA programme. District Horticulture Officer proposed, we may conduct training programme on potato cultivation during Rabi season and farmers may be motivated to go for onion cultivation though the support of ATMA	This has been included in the action plan for Rabi ATMA programme and approved in the Governing Body meeting and which will be placed in the District Strategy meeting scheduled on 19 th of this month for approval of	

Views of the participant attended the meeting

- DDH, Baripada appreciated the proposal of providing net to the villagers for preventing forest fire and he
 has also decided to adopt the technology in their plantation area and requested KVK to provide the
 specification along with cost of the net.
- Representative of ADR, RRTTS, Keonjhar advised to control Lantana Camara weed from the Similipal Bio Reserve Forest, action may be initiated from the Rainy season and the process should be continued for two three seasons for complete eradication.
- DDH stated 2250 qtl. of Potato seed is available for 150 ha. area, therefore, this may be informed to the
 farmers through KVK mobile advisory service. The seed cost is Rs.35.50 paisa per KG on plantation of
 seed there is a provision of Rs.20,000/- as subsidy to be provided to the farmers. Onion seed variety
 AFLR is also available with a subsidised rate of Rs.125/- per kg, which may be informed to the farmers
 through KMS.
- Representative of ADR, RRTTS, Keonjhar stated farmers may be motivated to go for tomato seed production programme of BT-10 variety.
- CDVO, Mayurbhanj proposed, KVK and line department to intervene with their scheme for restoration of livestock resources of the district through vaccination and nutrient supplement. He has also proposed to take up two villages of each block for visiting repeatedly to the selected villages in regular interval and government programmes may be implemented in that village. The same procedure must be followed for one year to make the village an ideal village. He has also emphasized on documentation and establishment of marketing hub of livestock.
- Training programmes on vaccination of poultry and dairy may be organized in the TRW residential school.
- KVK may be raised Mulberry and Glyricidia seedlings and supplied to the CDVO for nutrient supplement to the goat.
- It is decided two villages from five blocks of KVK, Mayurbhanj-1 & II operational area will be selected and the list will be provided by the In Charge, OLM, PD, DRDA, Mayurbhanj. After receipt of the list the Nodal officer may contact to the DLREI member for a meeting prior to visit the village.
- Odisha Livelihood Mission has agreed to provide support through its CIF scheme for overall development of the village.

The Chairman on his presidential address focused on the following points

- 1. Adoption of two villages of KVK operational blocks (10 blocks of each KVK) for one year by visiting repeatedly for its overall development.
- 2. Fixation of meeting after receipt of the village list from the OLM, PD, DRDA, Mayurbhanj.
