

PROCEEDING OF THE 3rd DISTRICT LEVEL RESEARCH-EXTENSION INTERFACE MEETING HELD ON 17TH AUGUST, 2016

The 3rd District level Research-Extension Interface meeting for the Mayurbhanj district was held on 17th August, 2016 under the Chairmanship of Sj.Narendra Kumar Behera, Dy.Director of Agriculture, Mayurbhanj. The meeting was started at 11.30 AM in the Conference Hall of KVK, Mayurbhanj-1. At the outset, the Senior Scientist & Head, KVK, Mayurbhanj-1 welcomed all the participants and requested to give self introduction. After brief introduction of the delegates, the Chairman urged for active participation in all discussions.

Review of the discussion of the previous meeting and action taken thereof:

,3.	Communication of research work to departments also should be there to ascertain their feedback which will help in designing future action plan.	The research programme of RRTTS is finalized and will be communicated to the members shortly.	
4.	Off-season vegetable cultivation should be promoted and it should be spread through the help of line department in upland rainfed farming situation.	The Senior Scientist & Head, KVK, Mayurbhanj-I & II informed they have taken programme on off season cultivation of tomato, cauliflower, brinjal and cabbage.	
5.	Animal health camp & vaccination camps should be conducted with the help of animal husbandry department.	np & vaccination Annual Health Camp will be organized ducted with the help shortly with the help of Veterinary deptt.	
6.	Creation of paravet workers to promote employment opportunity in specified villages.		
7.	Intercropping of plantation crops in watershed areas should be done in technical consultation with the KVK Scientists.	Discussed with the Watershed personnel and advised for plantation programme by Dr.S.Pattnaik	

Views of the participant attended the meeting.

- 1. The Horticulture Officer present in the meeting on behalf of the Dy. Director Horticulture suggested the project functioning under line department may be implemented in watershed areas.
- 2. All the members agreed on the proposal to visit the activities sites of each department and make SWOT analysis. According to the drawbacks the remedial measures will be decided later on.
- 3. All the members agreed to share their work plan, so as the committee can fix a date to move to the activities sites before the next District Level Research Extension Interface meeting.
- 4. As per the decision of the members, the PD, Watershed to submit the abstract of the project of watersheds and then the committee will visit the watershed areas and identify the need and planned accordingly.
- 5. On behalf of the DDH, the Horticulture Officer present in the meeting elaborated the schemes operated through their department.
- Inclusion of both the Forest & Irrigation department with the DLREI research and extension interface meeting suggested by the NGO DASI. The Chairman and the members present agreed with the proposal.
- 7. The officers present on behalf of the CDVO, Mayurbhanj proposed to take up fodder cultivation in the watershed areas.
- 8. The Veterinary department agreed to support in organization of animal health camp and as per the previous meetings recommendation, they will trained few paravet workers to promote employment opportunity in specified villages.
- 9. The Senior Scientist & Head, KVK, Mayurbhanj-1 requested the Veterinary department personnel to assist to follow-up the TSP programme of Banaraj Poultry distributed to the tribal groups in terms of vaccinations and medical check up.
- 10. The Scientist attending on behalf of the ADR, RRTTS, Keonjhar focussed in water harvesting by adopting the mechanized method in Rabi Pulse crop.

The Chairman on his presidential address focused on the following points

- 1.All the members have to share their plan and programme to the Committee very soon.
- 2. Before going for visiting the activities sites, the concerned line department has to arrange a pre-visit through their field personnel.
- 3. The committee will visit the site, identify the drawbacks and suggest the possible measures for better performance.
