## **Proceedings of the 4<sup>th</sup> District Level Research-Extension Interface meeting held on 20<sup>th</sup> September, 2016**

The 4<sup>th</sup> District level Research-Extension Interface meeting for the Mayurbhanj district was held on 20<sup>th</sup> September 2016, under the Chairmanship of Mr. Narendra Behera, Deputy Director, Agriculture, Mayrubhanj Range and in the presence of Dr. M. P. Nayak, Jt. Director (Information), OUAT. The meeting was held in the campus of KVK, Mayurbhanj-II and started at 11.30 A.M.

As convenor of the meeting, Senior Scientist & Head, KVK, Mayurbhanj-II welcomed all the delegates & after self introduction of all the participants, DDA was requested to chair and conduct the meeting as per agenda. Welcoming all, the Chairman have urged all for active participation in discussions.

In the beginning, Dr. M. P. Nayak, J. D. (Information) have briefed on the objective & usefulness of this type of meeting. He stressed on the systematic planning of the activities by proper analysing the prevalent situation and development strong linkage mechanism among different stake holders. He asked all the officials for put clear opinion & lively participation by giving critical feedbacks.

**Agenda-1:** The proceeding of the last meeting which was held on 17<sup>th</sup> August, 2016 at KVK, Mayurbhanj-I, Shamakhunta was discussed and the action taken thereof was presented as follows -

<b>Discussions of previous meeting</b>	<b>Action taken</b>
1. All the members have to share their plan & programmes.	1. As only Agriculture department has submitted the plan, all other departments are asked to submit before next meeting. A reminder is to be issued for further response
2. Joint visit of activity sites by all line department.	2. It was decided to take a joint visit on the next meeting date in afternoon session
3. Inclusion of forest & irrigation officials.	3. It was decided to write a letter to the District Collector & Magistrate on this issue.
4. Concentration of activities in the watershed areas.	4. The Chairman differed the idea and suggested for inclusion in all other areas.
5. Providing training to the paravet worker by the animal husbandry department with the help of KVK.	5. Due to absence of AH department officials, the decision was differed.

**Agenda-2:** The members participated from different departments elaborated the ongoing programmes. Agriculture department discussed on line transplanting of paddy under state plan, blockwise BGREI programme, Mung seed minikit programme under NFSM pulses, G.N. minikits & sesamum minikits under NMOOP. Along with DPD, ATMA have briefed on the ATMA activities. The NGO personnel from Back to Villages & Landesa have described their programme. The watsrhe department explained their programme on intercropping of maize in plantation areas & rabi vegetable cultivation demonstration in 500ha areas.

**Agenda-3:** As per advice of The Chairman, the joint programme & linkage mechanism will be finalised in the next meeting after receiving the detailed programme from all concerned.

To coordinate all the activities, it was decided to nominate Senior Scientist & Head, KVK, Mayurbhanj-I to act as nodal officer along with S. Moharana, DPD, ATMA & Dr. D. Mohanty, Scientist ( Ag. Engg.), KVK, Mayurbhanj-I will assist in this matter. All departments were asked to give their programmes & feedback to the nodal officer before the next meeting which is to be scheduled on 3<sup>rd</sup> Tuesday of next month.

On the basis of the discussions, the following decisions were taken for further course of action.

- a. All the heads of the district level offices in agriculture and allied sector was requested to attend the meeting by themselves only. In worst case, the second line officers may attend , but he should be well informed on the proceedings of the previous meetings.
- b. A joint field visit is to be carried out on the next meeting date in afternoon session, which will be co-ordinated by the convenor.
- c. The forest & irrigation officials may be invited and in this regard the District Collector & Magistrate should be intimated.
- d. The vegetable seedlings as required by the watershed department will be partially fulfilled by the KVKs as per their capacity. Balance seedlings may be procured by them from horticulture department. They are advised to develop community nursery with the technical help of KVK Scientists.
- e. The watershed department will provide fund for vocational training for the farmers to the KVK, Mayrubhanj-I with accommodation facility. The programme may be conducted in the campus of KVK, Mayurbhanj-II without any accommodation facility, if needed.
- f. ATMA will provide the fund for monitoring of BGREI programme to the KVKs.
- g. All the line departments will extend their help and presence as per need of others.

The meeting was ended with vote of thanks
