

The meeting was started at 11.30 AM in the KVK conference hall with a brief self introduction of the delegates.

Review of the major discussion of the previous meeting and action taken thereof:

The Senior Scientist & Head, KVK, Mayurbhanj-1 presented a brief report on activities of KVK, Mayurbhanj-1. The Senior Scientist & Head asked all the Scientists of KVK, Mayurbhanj-1 to present their activities one by one. Achievements of Rabi, 2015-16, Kharif, 2016 and programme for Kharif, 2017 and Rabi, 2017-18 of KVK, Mayurbhanj-1 were presented. The Senior Scientist & Head, KVK, Mayurbhanj-2 presented the achievement and action plan in the meeting. During the presentation, Senior Scientist and Head, KVK, Mayurbhanj-2 informed that the hybrid tomato variety- Swarna Sampad performs better yield and the mushroom variety OSM-11 produce yield of 2.2 kg/bed.

Remarks of the house

- 1. Farmers need designated research should be carried out in the field by the Scientists of KVK.
- 2. Greengram harvester should be taken in the pulse seed hub programme.
- 3. In DSR techniques harvesting time and sowing time should be mentioned.
- 4. In the absence of ADR, the representative of ADR will honour the Chairmanship instead of DDA.

Assistant Field Manager, IFFCO, Baripada suggested that farmers may be motivated to purchase agri inputs from MARKFED to avail the insurance benefit upto Rs.1.0 lakh in case of death and Rs.25,000/- in case of disability.
