
After briefing the objective of the District Level Research-Extension Interface Meeting, ADR, RRTTS, Keonjhar presented the house a comparative rainfall and temperature trend of both Keonjhar and Mayurbhanj district. He also presented the house the achievements of the Rabi, 2016-17 programme and action plan for 2017-18 of RRTTS, Keonjhar and suggested the line department official to take up / encourage climate resilient varieties based on the rainfall and temperature trend. The Chairman shared the research findings of by increasing dyke height of paddy field upto 20 cm can produce better yields.

Remarks of the house

1. Dr.Kundan Panda, Block Veterinary Officer of Shyamakhunta Block has proposed to incorporate programmes on fodder cultivation in the KVK action plan.
2. Mr.Nihar Ranjan Das, AFO, Shyamakhunta Block informed about the world fish collaborative programmes functioning under Fishery Department. The objective of the programme is to deal with malnutrition through carp – mola, polyculture and utilization of small and seasonal ponds through Tilapia and Amur carp culture.

The ADR in his presidential remark suggested both the senior scientist and heads to purchase GPS device for each scientist to record the data for their programmes. He also suggested to collect the information like AADHAR number and GPS locations of each farmers or beneficiaries of different mandatory activities carried out under the KVKs.

The meeting was ended with vote of thanks given by the Scientist (Agricultural Engineering), KVK, Mayurbhanj-I.
