

**PROCEEDINGS OF THE 13TH DISTRICT LEVEL RESEARCH
EXTENSION INTERFACE MEETING HELD ON 20TH JUNE 2017**

The 13th District level research extension interface meeting for the Mayurbhanj was held on 20th June, 2017 under the chairmanship of Dr. Srimanta Kumar Sahoo, Junior Scientist, Representative of ADR, RRTTS, Keonjhar. The meeting was started at 11.30 AM in the conference hall of KVK, Mayurbhanj-1.

At the outset, the Scientist (Home Science) read the proceeding of the previous Research Extension Interface meeting and action taken thereof. Then, she brought to the notice of all the members about the point advised by Hon'ble Vice Chancellor to be discussed in the DLREI meeting for identification of eligible Agri-Entrepreneurs. The Bankers are invited to attend the meeting. Field Officer, SBI, Shyamakhunta branch attended the meeting and expressed their difficulties in the process of selection of an eligible entrepreneur in delivery of credit for the agriculture and allied sector. The Bankers present during the meeting described the detailed credit criteria to the members and requested the line department official to forward a befitting proposal of eligible entrepreneurs in the field of agriculture and allied sector to consider for delivery of credit.

The Senior Scientist of both the KVKs have presented the action plan, 2017-18 of their KVK and the Scientists of both the KVKs have actively participated in the presentation and clarified all the queries related to selection of technologies.

- Programme on Assessment of Zn(@5kg/ha) and borax(0.5%) foliar spray on yield of rice to be re-casted
- OFT on Assessment of incubated Bio-fertilizer in yield of Cauliflower to be re-casted - suggested by DPD, ATMA, Mayurbhanj.
- OFT on Assessment of ITK methods for Control of pulse beetle in green gram to be re-casted - suggested by DPD, ATMA, Mayurbhanj.
- TSP programme on Introduction of White pig for livelihood support of tribal people to be dropped - suggested by AVAS, Shyamakhunta, DPD, ATMA, O/O DDA, Mayurbhanj and Senior Scientist & Head, KVK, Mayurbhanj-II.



Remarks of the House on the action plan & TSP 2017-18 of KVK, Mayurbhanj-II

- OFT on Assessment of Sprinkler irrigation in cauliflower to be dropped - suggested by DPD, ATMA, Mayurbhanj.
- Programme on Assessment of Drip irrigation in banana with mulching to be dropped - suggested by the chairman, Scientist Ag. Engg. KVK, Mayurbhanj-I.

DPD, ATMA, Mayurbhanj suggested, the results and recommendation of the successful programmes of both the KVKs may be circulated or communicated to all the line departments for follow for better dissemination of science and technology in the district.
