## <u>Proceeding of 34<sup>th</sup> District Level Research Extension Interface Meeting</u> held on 16<sup>th</sup> July 2019 at KVK, Mayurbhanj-II, Jashipur

The 34<sup>th</sup> District Level Research Extension Interface Meeting of Mayurbhanj district was held on 16<sup>th</sup> July, 2019 at KVK, Mayurbhanj-II, Jashipur. The meeting was stated at 11 A.M. under the chairmanship of Deputy Director of Agriculture, Mayurbhanj Sj. Damodar Sethi. This joint meeting of both KVKs of Mayurbhanj district was conducted amidst the representatives from line departments like NABARD, Agriculture, Horticulture, ARD, DIC and Fisheries along with RRTTS, Agri-preneurs, NGOs, and Entrepreneurs. At the outset, the Senior Scientist & Head of KVK, Mayurbhanj-II Dr. Deepak Kumar Mohanty welcomed the officials and after a brief introduction of the delegates he initiated the discussion and requested the chairman to preside the meeting. After the welcome address, the action taken report on the recommendations of the last R-E meeting was presented before the house by different stake holders. The Senior Scientist & Head of KVK Mayurbhanj-I, Dr. S. Pattnaik advised the members to suggest the programme which can be undertaken by the KVKs for the farming community of the district. Mr S.R. Pattnaik, DDM, NABARD discussed with entrepreneurs regarding status of sanction of project submitted to various departments and advised NGOs to converge their programme with KVKs and line departments.

#### Summary of Discussions and Recommendation

- Convergence of ARD on goetery in WARDI programme of NABARD.
- Strengthening of custom hiring centre developed by NGO PRADAN.
- Emphasis should be given in development of goatery shed from locally available materials.
- More focus on back yard poultry should be given specially on landless farmers benefitted in KALIA Yojana.
- Small amount loan should be promoted and encouraged.
- Date may be fixed by SS&H, KVK, Mayurbhanj-I and II with DDH, Mayurbhanj regarding discussion on sanction and finance of mushroom growers and linkage with bank with invitation to LDM, DDM, NABARD and DDA, Mayurbhanj.
- Guidelines of APC (Agricultural Production Cluster) scheme to be provided to line departments and KVKs by horticulture department for better implementation of the programme.
- Training on mushroom cultivation and maintenance of mushroom shed to the beneficiaries under OPELIP (Odisha PVTG Empowerment & Livelihoods Improvement Programme).
- Proposal on Agro service centre may be submitted to DIC for assistance.
- Technical assistance to fish growers under OPELIP (Odisha PVTG Empowerment & Livelihoods Improvement Programme).
- Linseed may be cultivated in available moisture after paddy harvest instead of paira.
- Feedback may be collected from farmers on regular basis after implementation of the programme.
- More awareness programme may be conducted to control of FAW in maize.
- Awareness on different schemes on backyard poultry and small Goatery unit for better livelihood of tribal farmers.
- Inter-cropping in maize based cropping system and IFS may be promoted in larger scale.
