**PROCEEDINGS OF THE 35th DISTRICT LEVEL RESEARCH EXTENSION INTERFACE
MEETING HELD AT KVK MAYURBHANJ-I ON 21st SEPTEMBER, 2019**

The District level research extension interface meeting of Mayurbhanj was held on 21st September, 2019 under the chairmanship of Dr.Damodar Sethi, DDA, Mayurbhanj. The meeting was started in KVK conference hall at 3.00 PM. After the welcome address by Dr.S.Pattnaik, Senior Scientist & Head, KVK, Mayurbhanj-1, Dr. D.K.Mohanty, SSH, KVK, Mayurbhanj-II informed the house about the action taken by DLREI members on the basis of the recommendation of the last DLREI meeting.

1.	Convergence of ARD on goatery in WADI programme of NABARD	Discussed with CDVO, Mayurbhanj and DDM, NABARD regarding the implementation of the programme.
2.	Strengthening of custom hiring centre developed by NGO PRADAN	
3.	Emphasis should be given in development of goatery shed from locally available materials.	Both the KVK of Mayurbhanj district have initiated in the their module villages.
4.	More focus on backyard poultry should be given specially on landless farmers benefitted in KALIA Yojana.	Both the KVKs have started distribution of poultry chicks under TSP programme.
5.	Date may be fixed by SS&H, KVK, Mayurbhanj-I and II with DDH, Mayurbhanj regarding discussion on sanction and finance of mushroom growers and linkage with bank with invitation to LDM, DDM, NABARD and DDA, Mayurbhanj.	Conducted a meeting on 14 th August, 2019 with DDH, Mayurbhanj and DDM, NABARD in the office chamber of DDH and discussed all details of sanction and bank linkage of mushroom growers.
6.	Guidelines of APC (Agricultural Production Cluster) Scheme to be provided to line departments and KVKs by horticulture department for better implementation of the programme.	Guidelines of APC (Agriculture Production Cluster) scheme have already been shared by Horticulture department.
7.	Training on mushroom cultivation and maintenance of mushroom shed to the beneficiaries under OTELIP (Odisha PVTG Empowerment & livelihoods Improvement Programme).	Discussed with Programme Officer, OPELIP and planned accordingly regarding implementation of the programme.
8.	Proposal on Agro Service Centre may be submitted to DIC for assistance.	Discussed with GM, DIC regarding submission of proposal on Agro service centre.
9.	Feedback may be collected from farmers on regular basis after implementation of the programme.	Both the KVKs are collecting feedback from farmers after implementation of OFT, FLD and TSP programme.
10.	More awareness programme may be conducted to control of FAW in maize.	KVK, Mayurbhanj-II have conducted one OFT, training programme. Awareness programme conducted by both the KVKs in collaboration with the department of Agriculture.
11.	Awareness on different schemes on backyard poultry and small Goatery unit for better livelihood of tribal farmers.	Awareness programme conducted in different module villages by both the KVKs with the support of ARD.

Summary of Discussion & Recommendation of the House

1. Support to BSS NGO by providing agricultural implements on subsidized rate for custom hiring and promoting mechanization.
2. Project proposal on entrepreneurship development through establishment of mushroom spawn and mushroom production unit to be routed through Horticulture department instead of KVK for ease sanction of loan from Bank

3. Establishment of demonstration units in KVK instructional farm out of ATMA fund.
4. DDA sharing the success of storage of groundnut seeds through pro gunny bags.
5. A discussion was held on different schemes like Vegetable seed production programme, hybrid vegetable cultivation, Farm Pond development, honey bee keeping and establishment of Zero Cool Chamber running under NHM programme. House proposed for sharing of information to the DLREI members on newly launched schemes and other ongoing schemes running under Horticulture department.
6. Development of entrepreneurship through establishment of mushroom spawn and production unit and mini rice mill under PMGB scheme by the financial assistance of DIC and for any query provided the address of the website i.e. www.KVIConline.gov.in/PMGB portal.
7. House concerned over simplification of loan sanction to the entrepreneurs and LDM discussed on scrutiny of documents and find out the Cibil Report of the beneficiary after receipt of the project proposal alongwith application form from the concerned department.

The meeting ended with vote of thanks by Scientist (Home Science), KVK, Mayurbhanj-1 at 5.00 PM.
