## PROCEEDING OF 44<sup>th</sup> VIRTUAL DISTRICT LEVEL RESEARCH EXTENSION INTERFACE MEETING HELD ON DATED 19/01/2021 AT KVK, MAYURBHANJ-1, SHYAMAKHUNTA

The 44<sup>th</sup> District Level Research Extension Interface meeting was held on 19<sup>th</sup> April, 2021 under the Chairmanship of the Chief District Agriculture Officer, Mayurbhanj. The meeting was started in KVK conference hall at 11AM. At the outset, the Senior Scientist & Head of KVK, Mayurbhanj-1, Dr.Sanghamitra Pattnaik welcomed the officials from different departments attended the said meeting. After the welcome address Dr.D.K.Mohanty, Senior Scientist & Head, KVK, Mayurbhanj-II informed the house about the action taken by DLREI members on the basis of recommendations of the last meeting. Both the KVKs of Mayurbhanj presented their respective Annual action plan for the year 2021-22.

Sl.No.	Recommendation of the 43 <sup>rd</sup> DLREI	Action Taken
1.	CDAO, Mayurbhanj suggested the popularization of Balaram scheme for landless farmers and share croppers. Furthermore, he also requested to create awareness among the farmers to submit project proposals under MKUY(Mukhyamantri Krishi Udyog Yojana) to avail 50% subsidy. He elaborated other Govt. schemes like Agro Infrastructure Fund(AIF),Doubling farmers income & urged the house to aware among farmers to contact Agril. Department for further details	The information on the Balaram scheme and Mukhyamantri Krishi Udyog Yojana has been shared in various platform for the benefit of the farmers.
2.	DFO, Mayurbhanj, suggested for conducting demonstrations and training programme for popularization of Biofloc fish farming in the district.Ornamental fish rearing should be popularized by KVKs.	One number of OFT on Biofloc fish farming and six numbers of training programme has been included in the Action Plan 2021-22 of KVK Mayurbhanj-I
3.	DDH, Mayurbhanj suggested for the development of cold storage facility and facilitation of bank loans for resource poor farmers.	Famers have been encouraged to avail the facility
4.	JDE(Information), OUAT stressed upon popularization of pisciculture and other livelihood activities like Apiary and Poultry	KVK has formulated TSP, FLD and other awareness programme for the popularization of pisciculture, Apiary and Poultry in the district.
5.	CDVO suggested for the popularization of both layer and broiler poultry farming alongwith goatery among the small/marginal farmers as an enterprise.	Farmers have been encouraged in different training and awareness progamme to take up layer, broiler poultry farming and goatery as an enterprise
6.	ADR, Keonjhar requested for collection and preservation of local germplasm of Linseed to promote research and production of Linseed for further development of a Centre of Excellence on Linseed.	Farmers have been communicated to collect the local germplasm of Linseed for the promotion of Research Programme.
7.	LDM, Mayurbhanj suggested the field functionaries to look into the renewal of crop loans for better credit management to the farmers	Requested the All District line department official to follow up the renewal of crop loan.

## Summary of discussion and recommendation

- 1) CDAO, Mayurbhanj suggested for the inclusion of different observation parameters and STBR on OFT programme on Assessment on use of gypsum and phosphorus solubilising microbes for groundnut cultivation of KVK Mayurbhanj-I.
- 2) DDH, Mayurbhanj suggested for the Polyhouse technology instead of Fogger for the Assessment of humidity management in paddy straw mushroom production
- 3) CDVO suggested for the poultry Breed "Aseel" as TO<sub>1</sub> and "Pallishree /Kalinga brown" as TO<sub>2</sub> in the OFT programme on Assessment of Poultry breed in Backyard

- 4) The Scientist (Ag. Extension), KVK Mayurbhanj-II suggested for the Group discussion, Interactive lecture as TO<sub>1</sub> in the OFT programme on Assessment of effectiveness of different extension methodologies on Paddy Production.
- 5) CDAO, Mayurbhanj suggested for the modification of details of technology in the Demonstration programme on Application of Bensulfuron-methyl and Pretilachlor for Weed infestation in Paddy of KVK Mayurbhanj-I.
- 6) The house suggested for the selection of Ideal village of Horticulture by the department of Horticulture for the implementation of different programmes.
- 7) The DDM, NABARD informed the house on the formation of FPO on Fishery.
- 8) The ADR, RRTTS, Kenojhar suggested for the inclusion of protein rich rice varieties in the OFT programme.
- 9) The AFO, Shamakunta representative of DFO, Mayurbhanj proposed for the seed availability of Red-Tilapia and Amur carp at KVK Mayurbhanj-I but as suggested by Scientist (Fishery Sc.), KVK Mayurbhanj-I as sufficient infrastructural facility is available at Kathpal and Badjhore fish farm under DFO, Mayurbhnaj, so the above seed rearing practices may be undertaken by the department of fishery with the technical support of KVK Mayurbahnj-I
