## PROCEEDING of 53<sup>rd</sup> District Level Research Extension Interface Meeting Held on at 28.09.2022

The 53<sup>rd</sup> District level Research Extension Interface meeting was held on 28<sup>th</sup> September, 2022 under the chairmanship of the ADR, RRTTS, Keonjhar. This joint meeting of both KVK of Mayurbhanj district was conducted amidst the officers and representative from different line departments like District Fisheries Officer, DDM-NABARD, RM, OGB, ACF, Karanjia, BVO, DIC, OIIPCRA, Millet Mission, NGOs & along with Agrientrepreneurs as annexed herewith are joined and participated in the discussion.

The meeting was started at KVK, Mayurbhanj-II, Jashipur at 11 am by the welcome address of Senior Scientist and Head.

At the outset Scientist (Agril Extension), KVK, Mayurbhanj-I informed the house about the action taken by DLREI members on the basis of recommendation of the last Meeting.

5	GM, DIC requested all line department officials to take the initiative for selection of entrepreneurs from FPOs and SHGs to set up enterprise in Agro based industries by taking the advantages of MSME & PMEGP loan	Already taken initiative by all departments but any proposal yet to send to DIC.
6	Precautionary control measures for controlling of Wasp to be circulated among the Tasar growers as requested by Scientist, BSMTC, Baripada	Taken initiative by KVK, Mayurbhanj-I
7	Climate resilient notified vegetable varieties to be	Both the KVKs along with

	popularized among the farmers as per the suggestion of Agri Expert of OIIPCRA, SOPMT, Zone-6	horticulture department taken initiatives in their respective programme
8	ADR, RRTTS, Keonjhar suggested for line sowing of non-paddy crops	KVK, Mayurbhanj-II already included line sowing of maize and mustard in its action plan. Agriculture department and KVK, Mayurbhanj-I also taken initiatives in this regard

## Summary of discussion & recommendation:

- ADO, Jashipur suggested for cultivation of pumpkin, cowpeas in fallow land to mitigate the adverse situation arises due to climate change during Kharif season.
- ADR, RRTTS, Keonjhar emphasis on categorization of fallow land to go for proper planning of crops according to agro-climatic and agro-ecological situations in fallow land.
- 3) ADO, Karanjia given emphasis on need based training programme to be conducted on IPM practices of paddy as evidence of BPH has been seen due to fluctuation of temperature and humidity according to climate change.
- 4) Team Leader, OIIPCRA viewed his thought on emphasis of allied sectors on Apiary, Silkworm cultivation and Agro-forestry. He also suggested for mechanization in maize and millet cultivation and seeks help from both the KVKs.
- 5) DFO, Mayurbhanj viewed his thoughts on different types of training and its constraints. He suggested on the improvement of the training programme through demonstration of technology in small and cluster scale for higher adoption.
- 6) He also stated on enterprise and entrepreneurship development of the district to create example/success stories and action taken on that particular enterprise and entrepreneur on next meeting. He has requested KVKs and line departments to propose one villages each from their jurisdiction where all departments and KVK to work on their activities for overall development of those villages.
- 7) DDM, NABARD emphasises on work on farm pond and FPOs. Requested all line departments along with both the KVKs to expand their work on revival of some FPOs and involve themselves in capacity development programme of different FPOs in the district.
- 8) ACF, Karanjia stressed upon awareness on plantation of Agro-forestry and requested all members to work on this aspect with the help of forestry departments.
