PROCEEDING OF 55th DISTRICT LEVEL RESEARCH EXTENSION INTERFACE MEETING HELD ON DATED 24/11/2022 AT KVK, MAYURBHANJ-1, SHYAMAKHUNTA

The 55th District Level Research Extension Interface meeting was held on 24th November 2022 at KVK Mayurbhanj-I campus under the Chairmanship of the ADR, RRTTS, Keonjhar. The meeting was started in KVK conference hall at 3.30pm. amidst representatives from line departments like Agriculture, Horticulture, Fishery, Animal husbandry, Soil conservation, Sericulture, LDM,DDM,NABARD DIC,NGOs along with Agri-entrepreneurs. At the outset, the Senior Scientist & Head of KVK, Mayurbhanj-1, Dr.Sanghamitra Pattnaik welcomed the officials of the line departments. After the welcome address, the Senior Scientist & Head, KVK, Mayurbhanj-II informed the house about the action taken by DLREI members on the basis of recommendations of the last meeting.

1.	To ensure nutritional security, DDH, Mayurbhanj suggested to identify the malnourished family in the district by the DSWO for distribution of vegetable and fruit saplings. He also suggested to include DSWO & DPC,Missionsakti in the RE meeting.	The DSWO,Mayurbhanj has been communicated to provide the list malnourished family in the district.
2.	To make farmers self-sufficient & not depending on neighbouring states, farmers to produce more potatoes suggested by DDH,Mayurbhanj & to preserve it in cold storages for longer period, Govt. is supporting farmers 70% subsidy on transportation & cold-storage charges.	Two(2) nos of awareness programme have been conducted & encouraged farmers for Potato cultivation by availing Govt.subsidy
3.	CDVO, Mayurbhanj emphasized on promotion of Broiler farming through training programmes for the extension workers.	For the promotion of Broiler farming, both the KVKs have taken initiative to undertake the training programme with the help of the Dept.of ARD.
4.	PD, Watershed urged technical support from all the Line departments for the success of the Green Agriculture Project in the district.	We all are committed for the success of Green Agriculture Project in the district
5.	The Business Manager, ORMAS suggested for providing training regarding technical know-how on pesticides & fertilizers to their field functionaries	The same will be implemented soon
6.	The Manager, DIC, Mayurbhanj emphasized on the scope and importance of the food processing industry in the district and encouraged for the promotion of food processing and value addition of agro-commodities in entrepreneurship mode through MSME schemes.	Taken initiative by all the line departments; but yet to send the proposal
7.	LDM, Mayurbhanj suggested for providing more number of training programmes on Fishery and Bee keeping to the rural youth for sustainable livelihood.	With the suggestion of LDM,Mayurbhanj,both the KVKs will include training programmes on Fishery & Bee-keeping for RY in our future action plan
8.	Precautionary control measures for controlling of Wasp to be circulated among the Tasar growers as requested by the Scientist , BSMTC, Baripada	Prepared it & the same will be communicated
9.	The house recommended the next RE-Linkage meeting will be conducted in a nearby village followed by joint visit by the members.	The next RE meeting will be conducted in a nearby village of Jashipur

Salient Recommendations

- CDAO, Mayurbhanj suggested for popularization of rice-fallow varieties and undertaking varietal trials for the non-paddy crops suitable for the district.
- DDH, Mayurbhanj emphasized on encouraging potato, onion and hybrid vegetable cultivation to boost production and become self-reliant in vegetable production. He also called for popularization of profitable crops like dragon fruit and apple ber in the district.
- In an attempt to attain self sufficiency in milk production, CDVO, Mayurbhanj suggested for promoting dairy enterprise to increase A2 milk production and its value addition.
- LDM, Mayurbhanj focused on improving market force and marketing channels for major crops and its allied value added products.
- PD Watershed, Mayurbhanj emphasized on the importance of preservation of local and indigenous varieties and land races due to their genetic diversity and advocated for the incentivization of farmers for production of local and indigenous varieties.
- The Manager, DIC, Mayurbhanj suggested for promotion of Agri and food processing industries in entrepreneurship mode to reduce distress sale and wastage of perishable products and increase profitability.
- OPIICRA personnel emphasized on popularization of nano urea among the farmers through different training and demonstration programmes.

The meeting ended with vote of thanks by Dr. Jagannath Patra, Scientist(Ag. Extension) at 2.30 PM.
